The Greenbrier, White Sulphur Springs, West Virginia

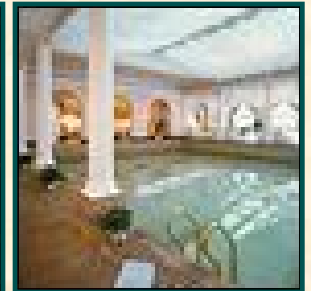
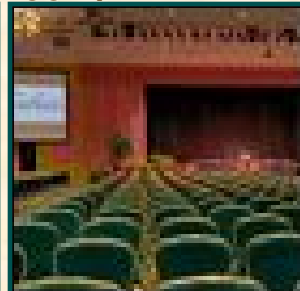
Room Rates \$289/night – We have locked in 20 rooms at this reduced rate. Call today to book as we will likely sell out!

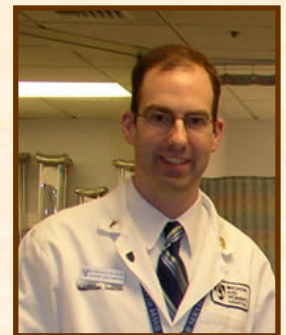


EDUCATION COMMITTEE

TREASURER'S REPORT

I would like to thank all the board members I had the pleasure of serving with and especially Jean Evans who was able to tie the pieces together for me. After this newsletter, I will be transitioning the responsibilities of the Treasurer/Secretary to Will Clark's capable hands.

We currently have \$38,928.93 in our checking account and continue to be on track with respect to our budget. The most pressing develop as an organization is that the IRS now requires us to renew our tax exempt status every three years. This means that we will need to file a tax return which we have completed for the 2009. While the tax Exempt status doesn't affect the mission of ASSET it certainly gives us certain tax advantages which we should maintain.

In the past , we have worked very hard as an organization to maintain our costs and to be good stewards of our revenue. As we consider a dues increase I wanted to share some of our current costs, looking at the Journal costs alone and not accounting for the difference in membership criteria, it cost us \$90 per member and \$125 per foreign member. A little more than half of our members now use Pay Pal as their preferred method of payments which deducts about 3.05% per transaction. Our three biggest expenses are the Annual conference, The Journal and Jean's secretarial support. Our three biggest sources of revenue are CEU course, Annual conference and membership dues.
