Just a few of the highlights included the first presentation by a foreign member, a joint symposium with the ASES and the first honorary awards presented to four outstanding ASSET members. Participation, interaction, collaboration and the sharing of clinical research and patient care intervention have always epitomized the essence of our fine organization.

The research committee will be gearing up to prepare for the upcoming meetings in Sonoma. Just a reminder that they are available to help you with your research project, analysis or presentation ideas.

This year we will once again offer *“Quenching and Questions”* a wine and cheese hosted by the research committee that allows people to ask research related questions in a less formal atmosphere. Any question is welcome. Last year topics included what outcome measures to use, how do you have enough time to do data collection, and conducting literature searches.

#### Case study :

How about a case study section of presentations at ASSET? A block of time hosting 4-5 case studies of challenging or interesting patients and what we did to manage them. Greetings and Salutations from the Education Committee,

I hope that everyone is having a pleasant spring and enjoyable holidays. The education committee has been working to develop their component of our 2001 meeting in Wine County. Maybe we should all just drink wine and have a good time (oops!!). During our meeting in Austin, the Education Committee came up with a number of topics that would be interesting to all of us. Of course we are in the development stages so we would appreciate input and ideas from anyone of you. We hope to include instability and look at the relationships to, slap lesions, impingement, and rotator cuff tears. Thermal Capsulorrhaphy is a relatively new and certainly controversial procedure. We hope to have the surgeons update us on the indications, ra-

tional for its use and the pitfalls and complications that have been seen in its development. Bryce Gaunt from the Houghton Clinic has offered to contribute on this topic and address rehabilitation. Other topics considered include proximal humeral fractures, the weak shoulder, biceps tendon pathology, the stiff elbow, and the unstable elbow. We encourage all members to present any topic concerning shoulder and/or elbow that interests them. The education committee will be contacting those members who are required to present this year to maintain or move to active membership. Case studies are great learning tools and fulfill the requirements for active member status. For those of you who have to present there is plenty of time to put together an interesting case or topic of your choice. As always, the surgeons have been most gracious and willing

to present and interact with our group. We have contacted Dr. Gary Gartsman who is president elect and as tradition has it, will address us on a topic that has not been decided upon.
